

GFCI outlets are the tiny household devices that sit quietly near sinks, garages, basements, and outdoor hose bibs, waiting for somebody to do something foolish with water and electricity. They are not glamorous. Nobody tours a house and says, "Forget the quartz countertops, show me the ground-fault protection." Yet these outlets prevent shocks, reduce electrocution risk, and keep homes closer to electrical code than many owners realize.

A standard outlet is mostly concerned with delivering power. A GFCI outlet, short for ground-fault circuit interrupter, is concerned with whether that power is trying to escape through a person, a puddle, a wet appliance, a faulty cord, or some other path that would make an Electrician mutter words not found in the code book.

If you own a home, remodel kitchens, manage rental property, or have ever pressed the "reset" button on an outlet with the solemn uncertainty of launching a rocket, this guide is for you. It explains where GFCI protection belongs, why code keeps expanding its use, what goes wrong in real houses, and when a DIY reset becomes a job for a licensed pro.

What a GFCI outlet actually does

A GFCI device monitors current flowing out on the hot conductor and returning on the neutral conductor. Under normal conditions, those amounts should match closely. If electricity leaves one way and does not come back the expected way, the device assumes some current may be leaking through an unintended path. That path might be a wet hand, a metal appliance housing, a damp concrete floor, or the world's least charming combination of all three.

When the imbalance reaches roughly 4 to 6 milliamps, a typical GFCI trips quickly, often in a fraction of a second. That tiny number matters. A standard breaker may not trip during a small ground fault because the current is nowhere near the breaker's 15 or 20 amp rating. A GFCI reacts to leakage, not just overload.

That is the key distinction. Circuit breakers protect wiring from overheating and fire. GFCI protection helps protect people from shock. Arc-fault protection, another code requirement in many areas, targets dangerous arcing that can start fires. These devices are related in the same way a smoke alarm, seat belt, and umbrella are related: all protective, all different, and none of them especially fun to replace after they fail.

The little "test" and "reset" buttons on a GFCI are there because the device contains electronics and mechanical contacts. It is not just a fancy outlet face. Pressing "test" creates a simulated fault and should cut power. Pressing "reset" restores it, assuming the device is wired correctly and the fault is gone. If it refuses to reset, the outlet may be telling the truth. Homes would be easier if every failed device produced a polite written explanation, but we get tiny buttons instead.

Why GFCI code rules keep spreading through the house

Electrical codes are not written because someone in a windowless room enjoys making bathroom remodels more expensive. Most rules are paid for in accident history. Wet locations, grounded surfaces, extension cords, power tools, pumps, appliances, and outdoor circuits have all shown enough risk over the years that code-making panels tightened requirements.

The National Electrical Code, often called the NEC, is updated every three years. Local jurisdictions adopt versions on their own timelines and may add amendments. That means code in one city can differ from code in the next county over. A home built in 1982 is not automatically illegal because it lacks modern GFCI coverage everywhere, but any new work usually must meet current local code. If you remodel a kitchen, add a receptacle in a garage, install a new outdoor outlet, or run power to a heat pump installation, the current rules likely apply to that work.

This is where homeowners get tangled. They ask, “Wasn’t this legal when the house was built?” Maybe. But “legal then” and “safe enough now” are not twins. They are cousins who only see each other at awkward family events.

A good Electrician looks at the age of the home, the scope of new work, the local code cycle, the panel condition, and the devices involved. Code compliance is not just about slapping in a GFCI where one is missing. It is about making sure the entire circuit behaves properly, grounds are present where expected, boxes have enough room, load and line terminals are not reversed, and downstream protection is clear instead of mysterious.

The places GFCI protection usually belongs

Rules vary by adopted code, but GFCI protection commonly appears in bathrooms, kitchens, garages, unfinished basements, crawl spaces, laundry areas, outdoors, boathouses, accessory buildings, and areas near sinks. Newer code editions have expanded requirements for appliances and certain equipment, including items that once sailed through inspections without much fuss.

Bathrooms are the classic GFCI zone. Hair dryers, curling irons, electric razors, wet hands, and tile floors create a greatest-hits album of shock hazards. Kitchen countertop receptacles are another big one. Coffee makers, blenders, toaster ovens, instant pots, and the occasional phone charger all gather near sinks and grounded surfaces. Garages and unfinished basements matter because people use tools, extension cords, freezers, sump pumps, and battery chargers on concrete floors that may be damp. Outdoors, rain and irrigation systems make the case without much courtroom drama.

Laundry areas have become more important as code has evolved. Washing machines, utility sinks, and concrete floors are enough reason for caution. Crawl spaces and unfinished basements can hide receptacles for sump pumps, condensate pumps, dehumidifiers, and other equipment that fails at 2 a.m. Because equipment has a wicked sense of timing.

Then there are modern mechanical systems. An Air conditioning contractor or Heating contractor may need proper receptacle access for service near outdoor condenser units, furnaces, boilers, or air handlers. Depending on location and local code, those service receptacles may require GFCI protection. A Furnace repair service technician should not have to plug a work light or meter into a questionable outlet while kneeling next to metal equipment. The same goes for an Air conditioning repair service working around wet pads, condensate, rain, and grounded equipment cabinets.

A Lighting contractor may encounter GFCI requirements on exterior lighting controls, landscape lighting transformers, or receptacles added for maintenance access. A Gas installation service may not be doing the electrical work, but modern gas appliances often involve igniters, controls, blowers, condensate pumps, and bonding concerns that bring electrical safety into the conversation. Trades overlap more than customers expect. A Plumber replacing a disposal, a contractor performing water heater installation, or a technician handling water heater repair may all discover that the nearby receptacle arrangement is outdated or unsafe.

GFCI outlet, GFCI breaker, or dead-front device?

GFCI protection can be provided in several ways. The familiar receptacle with buttons is only one option. A GFCI breaker in the electrical panel protects the entire circuit. A dead-front GFCI device looks like a blank faceplate with test and reset buttons and is often used where protection is needed but plug access is not.

Each approach has trade-offs. A GFCI receptacle is affordable and easy to [Plumber](#) identify. It can protect itself and, if wired correctly, downstream outlets. This is useful in kitchens, bathrooms, and garages. The downside is confusion. One tripped device may shut off outlets in another room, and homeowners may spend an afternoon blaming the freezer when the real culprit is a tripped outlet behind storage bins.

A GFCI breaker protects the whole circuit from the panel. This can be cleaner for outdoor circuits, multi-outlet garage circuits, crawl space receptacles, or locations where a receptacle device would be hard to reach. It also avoids having GFCI electronics installed in damp or harsh spots. The downside is cost and compatibility. Some older panels do not accept modern GFCI breakers easily, and certain multi-wire branch circuits require careful handling. This is not the place for guesswork and a screwdriver inherited from your uncle.

Dead-front devices are handy for equipment circuits, spas, whirlpools, and certain layouts where the reset point belongs in an accessible interior location. They are less common in everyday homeowner conversation, mostly because nobody brags about a blank plate at dinner.

A professional chooses based on access, nuisance trip history, panel type, circuit layout, local rules, and the human factor. If resetting the device requires moving a washing machine, crawling behind a freezer, or explaining to a tenant which of six identical outlets controls the garage door opener, the design has already lost style points.

Line and load: the two words that ruin many Saturday projects

A GFCI receptacle has line terminals and load terminals. The line side receives power from the panel. The load side sends protected power to downstream receptacles. Mix those up and the device may not work correctly, or it may refuse to reset. Some newer devices are designed to fail safe when miswired, which is good for safety and bad for the ego of the person installing it.

In older homes, box wiring can be surprisingly creative. I have opened bathroom outlets where the white wires were not all neutrals in the practical sense, grounds were missing, and a downstream outlet in the hallway somehow depended on a connection made behind a medicine cabinet. Electricity always follows physical paths, not the hopeful diagram in someone's head.

Shared neutrals add another wrinkle. Multi-wire branch circuits can be perfectly legitimate when installed correctly, but GFCI protection must account for the shared neutral. If not, tripping can occur instantly or unpredictably. Kitchens in older homes sometimes have split receptacles or multi-wire circuits that were common practice in their era. Replacing devices one-for-one without understanding the circuit can create problems that did not exist before.

This is why an outlet tester, while useful, is not a complete diagnostic tool. The little three-light tester can catch many common wiring errors, but it cannot prove every condition is safe. It may not reveal bootleg grounds, shared-neutral issues, poor terminations, or load-side confusion. It is a decent first look, not a license to declare the electrical system spiritually cleansed.

Common GFCI problems seen in real homes

GFCI issues tend to show up as either nuisance trips, failure to reset, dead downstream outlets, or repeated failures. The trick is separating a bad device from a real fault. Replacing a GFCI that keeps tripping without investigating the load is like putting tape over a check-engine light and calling yourself a mechanic.

Outdoor outlets take the most abuse. Weather-resistant covers help, especially in-use bubble covers that protect cords while plugged in. Still, water finds bad gaskets, cracked covers, low-mounted boxes, and old cable entries. Add holiday lights, lawn tools, pond pumps, or a pressure washer, and the circuit has plenty of chances to complain.

Garages create their own chaos. Freezers, battery chargers, garage door openers, shop vacs, and power tools all end up on receptacles that may share one GFCI. A freezer on GFCI protection can raise concern because a trip may spoil food. Code may still require protection depending on location and adopted rules. The practical answer is not to remove safety protection. It is to use dedicated circuits where appropriate, choose quality equipment, correct faults, and consider alarmed temperature monitoring for valuable stored food. A freezer full of venison deserves better planning than “hope nobody notices the blinking outlet.”

Bathrooms often trip because of hair appliances, worn cords, or moisture. Kitchens bring small appliances into play. A toaster with crumbs and internal leakage may trip a GFCI honestly. Dishwashers, disposals, refrigerators, microwave circuits, and under-sink outlets have their own code considerations, especially in newer installations.

Mechanical rooms can be sneaky. Condensate pumps, water softeners, recirculation pumps, and service receptacles live near water and equipment grounding paths. A water softener installation may add equipment that needs nearby power. Plumbing leak repair around electrical devices can leave moisture in boxes. Drain cleaning, Rooter service, and Hydrojetting can happen in basements or utility areas where cords and wet floors share space. A Septic system service call may involve pumps, alarms, floats, and outdoor electrical components that absolutely deserve proper GFCI protection and weatherproofing.

Air conditioning maintenance and an Air conditioning tune-up can also reveal GFCI problems. Outdoor service receptacles may be cracked, loose, unprotected from weather, or dead because a GFCI in the garage tripped months earlier. During Air conditioning repair, technicians often need safe temporary power for tools or diagnostic equipment. Nobody should be choosing between finishing the repair and trusting a corroded outlet next to a condenser pad.

When a GFCI trip is doing you a favor

A trip is annoying. It is also data. The device detected enough imbalance to shut down. Sometimes that imbalance comes from a faulty appliance. Sometimes moisture entered a box. Sometimes a neutral touches ground downstream, which can trip a GFCI even when no load is plugged in. Sometimes the GFCI itself has aged out.

GFCI devices do not last forever. Lifespan varies by environment, usage, surge exposure, humidity, and device quality. Many last 10 years or more indoors. Outdoor and garage devices may fail sooner, especially with heat, cold, moisture, dust, and enthusiastic spiders. Modern self-testing GFCI devices periodically check their own function and may indicate failure with a light or refusal to reset.

Repeated trips after rain strongly suggest moisture intrusion. Trips when a specific appliance runs point toward that appliance or its cord. Trips with nothing plugged in may indicate downstream wiring damage, a ground-neutral fault, or a failing device. Trips after recent plumbing work may mean water entered a box or disturbed a cable. Trips after remodeling may mean someone drove a fastener where fasteners should not go, a classic move in the grand tradition of finding wires with screws.

Before calling for service, a homeowner can do a small amount of sensible observation. Press test and reset if it is safe. Unplug devices on that circuit. Note whether the trip happens immediately, during rain, when an appliance starts, or after a delay. Do not keep forcing reset over and over. A GFCI is not a stubborn vending machine. If it trips again, assume it has a reason until proven otherwise.

A homeowner's quick safety check

Use this short check only as a visual and functional review. It is not a substitute for testing by a qualified Electrician, especially in older homes, rental properties, or any home with prior DIY electrical work.

- Press the test button on accessible GFCI outlets monthly or at least a few times a year, then confirm reset restores power.
- Look for cracked covers, loose outlets, missing weatherproof covers, scorch marks, buzzing, or warm faceplates.
- Check bathrooms, kitchens, garages, unfinished basements, laundry areas, crawl spaces, and outdoor receptacles for GFCI protection where expected.
- Unplug and stop using any appliance or cord that trips multiple GFCIs.
- Call a licensed electrician if a GFCI will not reset, trips with nothing plugged in, or controls outlets in confusing locations.

That is one list, and it earns its keep. Most electrical safety is not dramatic. It is noticing the small ugly thing before it becomes the large expensive thing.

Code compliance during remodels and service work

Home code compliance becomes especially important when multiple trades are involved. A kitchen remodel may bring a Plumber for sink relocation, a Lighting contractor for recessed fixtures, an Electrician for small-appliance circuits, and perhaps an Air conditioning contractor if ductwork or ventilation changes. Each trade touches a different system, but the final installation has to behave as one house.

Consider an under-sink cabinet. You may have a disposal, dishwasher connection, water filtration system, instant hot water dispenser, and sometimes a leak detector or recirculation pump. Add plumbing leak repair history and a cabinet floor that has seen better days, and GFCI protection is not a luxury. It is common sense wearing a code-approved hat.

Laundry renovations can create similar issues. A washing machine outlet, gas dryer controls, electric dryer circuit, utility sink, and nearby furnace equipment may all share tight quarters. A Heating contractor performing furnace replacement or a Furnace repair service technician may find that the service receptacle lacks GFCI protection or that the equipment bonding needs attention. A Gas installation service installing a new gas line for a dryer or furnace might not be responsible for the receptacle, but the project still needs coordination. Gas and electricity have a long history of demanding respect, and neither appreciates improvisation.

Basement remodels are notorious. What begins as "let's finish the basement" turns into questions about sump pumps, sewage ejector pumps, dehumidifiers, HVAC equipment, water heater repair, water heater installation, and maybe plumbing repiping if old galvanized piping finally gives up. Add a home gym, a wet bar, and a bathroom, and suddenly GFCI and AFCI requirements are not side notes. They shape the circuit design.

Outdoor projects matter too. Patios, hot tubs, irrigation controllers, landscape lighting, detached garages, and heat pump installation all raise electrical code questions. Equipment clearances, disconnect locations, service receptacles, burial depth, conduit type, bonding, and GFCI protection may all come into play. The cleanest projects happen when the electrical plan is not left until the last afternoon, when everyone is tired and the concrete truck is already scheduled.

Old houses, two-prong outlets, and the grounding question

Many older homes have two-prong receptacles and no equipment grounding conductor in some circuits. Owners often want three-prong outlets because modern plugs demand them. The safe and code-compliant options depend on the wiring method, local code, and whether a proper ground exists.

A GFCI can be used in some cases to replace a two-prong receptacle where no equipment ground is present, provided it is labeled properly as “No Equipment Ground” and installed according to code. This improves shock protection, but it does not create a true equipment ground. Surge protectors, sensitive electronics, and certain appliances may still lack the grounding path they expect.

This detail gets missed constantly. A three-prong receptacle without a ground can look reassuring while doing less than people assume. It is the electrical version of wearing a lab coat to fix a sandwich. The appearance suggests competence, but the substance may be missing.

Rewiring or adding grounded circuits may be the better long-term solution, especially for kitchens, home offices, workshops, laundry equipment, HVAC equipment, and appliances. It costs more than swapping devices, but it gives the system a proper foundation. In homes with knob-and-tube wiring, old cloth cable, damaged insulation, overloaded circuits, or questionable splices, GFCI upgrades should be part of a broader safety evaluation.

Nuisance tripping versus real hazards

The phrase “nuisance trip” gets used loosely. Sometimes it means the GFCI is too sensitive or incompatible with equipment. Sometimes it means the device is correctly detecting leakage current. The difference matters.

Certain appliances and equipment naturally produce small leakage currents because of filters, motors, heaters, or electronic controls. One device may be fine. Several on the same circuit may add up. Long outdoor cable runs can also contribute leakage, especially when moisture enters. Variable-speed equipment, pumps, and older motor loads can complicate troubleshooting.

That does not mean removing GFCI protection is the answer. The better approach is to isolate loads, inspect wiring, use appropriate devices, dedicate circuits where needed, and replace faulty equipment. For example, a condensate pump that trips a GFCI may have internal moisture or winding leakage. A refrigerator that trips after defrost cycles may need appliance service. An outdoor outlet that trips only during storms likely needs weatherproofing, not a pep talk.

Quality matters too. Cheap devices from questionable sources are not a bargain when they guard wet-location circuits. Use listed devices from reputable manufacturers. Weather-resistant and tamper-resistant ratings should match the location and code requirements. Outdoor boxes need proper covers and gaskets. Cable entries need fittings rated for the use. Details like these separate a durable installation from one that spends every rainy week auditioning for a horror movie.

What inspectors look for

Electrical inspectors are not all identical, but GFCI inspection usually focuses on required locations, correct operation, accessibility, proper device rating, weather protection, labeling, and consistency with the adopted code. They may use a tester at receptacles, verify outdoor covers, examine panel breakers, and check whether protected downstream outlets are labeled.

Accessibility is a bigger issue than homeowners expect. A GFCI reset hidden behind a refrigerator, above a drop ceiling, or inside a cabinet packed with cleaning supplies may not satisfy practical access requirements. If the device trips, someone should be able to reach it without a scavenger hunt and a headlamp.

Labels matter when a GFCI protects downstream outlets. Those little stickers that say “GFCI Protected Outlet” and “No Equipment Ground” are not decorative confetti. They inform future owners, inspectors, and technicians. Of course, stickers fall off or get painted over, because houses enjoy mischief. Still, correct labeling at installation is part of doing the job properly.

Inspectors may also care about tamper-resistant receptacles in dwelling units, weather-resistant receptacles outdoors or in damp locations, proper box fill, secure mounting, correct cover plates, and conductor condition. A GFCI device hanging loose from a cracked box does not become acceptable just because the buttons work. Code compliance is the whole installation, not one heroic gadget.

The two tests that matter most

Testing a GFCI should confirm both the internal trip function and actual power interruption. Pressing the built-in test button is important because it uses the device’s internal mechanism. An external plug-in tester can also help confirm that the receptacle loses power and may identify some wiring problems. For a professional, additional testing may include verifying line-load configuration, checking downstream outlets, measuring voltage, inspecting grounding and bonding, and troubleshooting leakage paths.

Here is the short version worth remembering:

- The built-in test button should trip the device and cut power.
- The reset button should restore power only if the device is functioning and no fault remains.
- A plug-in tester can help, but it cannot diagnose every wiring defect.
- Downstream outlets may be protected by one upstream GFCI and should be labeled.
- Any test that produces heat, sparks, buzzing, smoke, or repeated tripping has ended the DIY portion of the program.

That is the second and final list. It is brief because electricity rewards clarity.

Why GFCI upgrades are not just an electrical issue

GFCI protection intersects with plumbing, HVAC, appliances, and home maintenance more often than people think. Water and electricity share walls, cabinets, basements, crawl spaces, garages, and exterior spaces. A Plumber performing drain cleaning may need safe power near wet floors. Hydrojetting equipment, Rooter service tools, and leak detection equipment often operate in damp areas. Plumbing repiping can expose old wiring problems or require bonding checks on metal piping systems. Water softener installation may add a powered appliance in a garage or utility room. Every one of these scenarios benefits from properly protected receptacles.

HVAC work tells the same story. Air conditioning maintenance, Air conditioning repair, and an Air conditioning tune-up often involve outdoor electrical access. A heat pump installation may require new circuits, disconnects, controls, and service receptacles. Heating equipment may involve condensate pumps, humidifiers, electronic air cleaners, smart thermostats, and service outlets. The Heating contractor and Electrician may both need to weigh in. If they do, let them. Trade coordination is cheaper than callbacks and safer than assumptions.

Water heaters are another example. Traditional gas water heaters may need power for draft inducers, controls, recirculation pumps, or nearby service equipment. Electric water heaters obviously need proper circuits, grounding, and disconnecting means. Water heater repair in a damp utility closet with an old non-GFCI outlet nearby is not a scene anyone should romanticize. Water heater installation is a good time to look at the electrical environment around the appliance, even when the heater itself is not the only load.

This is why good contractors develop peripheral vision. The best Electrician notices plumbing risks. The best Plumber notices unsafe outlets. The best Air conditioning contractor notices a missing weatherproof cover. Nobody has to do another trade's licensed work to recognize when the house is waving a red flag.

Permits, liability, and rental properties

Permit requirements vary, but new circuits, panel work, significant remodel wiring, and many equipment installations usually require permits and inspection. Simple like-for-like receptacle replacement may not always need a permit in every jurisdiction, but landlords, property managers, and sellers should be especially cautious. Rental properties carry higher liability because occupants depend on the owner to maintain safe systems.

If a tenant reports a bathroom outlet that sparks or a garage outlet that will not reset, treat it as a safety issue, not a maintenance annoyance. If a home inspector flags missing GFCI protection during a sale, do not automatically choose the cheapest patch. Ask whether the recommended correction actually matches current code and the home's wiring condition.

Insurance questions can also arise after electrical incidents. Poor workmanship, unpermitted work, and ignored hazards can complicate claims. Nobody wants to explain after a loss that their electrical strategy involved online advice, bargain-bin parts, and optimism.

A licensed Electrician brings more than labor. They bring code knowledge, testing equipment, insurance, experience with local inspectors, and the ability to spot related defects. Yes, that costs more than a plastic outlet and a Saturday afternoon. So does an ambulance, only with less convenient scheduling.

Practical upgrade strategy for homeowners

If your home is older or you are unsure about GFCI coverage, start with the highest-risk areas: bathrooms, kitchen countertops, exterior receptacles, garage outlets, unfinished basement receptacles, laundry areas, crawl spaces, and utility spaces. Have an electrician evaluate the panel and circuits before making widespread changes. In many homes, the best plan combines receptacle replacements, breaker upgrades, new dedicated circuits, and repair of damaged or outdated wiring.

Do not assume every outlet with buttons protects only itself. Map the circuit. Find out what dies when the device trips. This prevents surprises like a bathroom GFCI controlling an outdoor outlet, or a garage GFCI controlling a basement freezer. These arrangements may have been installed legally or conveniently at the time, but they can be inconvenient now. Clear labeling and sensible reset locations make the home easier to live with.

When remodeling, plan GFCI protection before cabinets, tile, drywall, and equipment placement lock everything in. Electrical design is much easier before the backsplash is installed and everyone is pretending a bad outlet location is "fine." It is not fine. It is just expensive to move now.

For outdoor circuits, invest in proper weather-resistant devices, in-use covers, suitable boxes, and correct mounting. Keep receptacles out of splash zones where possible. Avoid extension cords as permanent wiring, a phrase that should be printed on every garage wall in America. If holiday lights trip a GFCI every time it rains, the problem is not that the outlet hates festivities. Something is wet, damaged, overloaded, or poorly connected.

For mechanical equipment, ask the installer whether service receptacles, disconnects, condensate pumps, and controls meet current requirements. This applies to air conditioning repair, heat pump installation, furnace replacement, and water heater installation. A neat mechanical job with sloppy electrical support is like a tuxedo with flip-flops.

When to call an electrician without debating yourself

Some situations deserve immediate professional attention. Burning smells, scorch marks, buzzing, visible arcing, repeated trips, warm outlets, loose receptacles, water-damaged boxes, and GFCIs that will not reset are all strong signals. So are old panels with known hazards, aluminum branch wiring, knob-and-tube wiring, ungrounded three-prong outlets, and circuits that behave unpredictably.



Call before opening panels unless you are qualified. Panel work exposes live parts that can injure or kill. Even turning off the main breaker may not de-energize every component inside the panel. The service conductors remain live in many setups. This is not a bravery test.

Also call when multiple trades are involved and responsibility gets blurry. If a Plumber installs a disposal and the under-sink outlet is wrong, bring in an Electrician. If an Air conditioning contractor finds an unsafe service receptacle, fix it properly. If a Heating contractor replaces equipment and the existing circuit is questionable, do not bury the concern behind new sheet metal. Houses remember shortcuts, and they collect interest.

The quiet value of doing it right

A properly installed GFCI rarely gets applause. It trips when it should, resets when it can, and sits there looking unimpressed. That is exactly the job. Good electrical safety often feels boring, which is unfair because boring is what keeps kitchens, bathrooms, garages, basements, and patios from becoming emergency-room origin stories.

Home code compliance is not about chasing every new rule for sport. It is about understanding where risk lives and correcting it with sound workmanship. GFCI protection belongs in that category: modest cost, meaningful safety value, and plenty of room for mistakes if installed casually.

If your outlets are old, your outdoor covers are cracked, your garage GFCI trips whenever clouds gather, or your bathroom receptacle has not seen a test button since the Clinton administration, schedule an evaluation. The house will not write you a thank-you note, but it may stop trying to surprise you. That is a fair trade.
