

If a bus crash **truck accident lawyer** injured you around Atlanta, the deadline may be far shorter than you think.

The general Georgia deadline for injury suits is two years. A late notice can close a good claim before anyone looks at the merits.

Ownership determines almost everything here. Injuries on a public transit bus, a school bus, a private charter and a hotel shuttle each run on different rules. Ownership sets the notice requirement, the immunity questions and what insurance responds.

There is a second deadline nobody announces. Transit and charter buses carry multiple cameras, and retention is often measured in days or weeks. Ask too late and there is nothing left to preserve.
