

If you or your child were bitten around Atlanta, Georgia works differently than people expect.

In some places an owner is liable automatically. That is not the Georgia rule. The question is normally whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal [best personal injury lawyer](#) was restrained and whether anyone contacted animal control.

These records fade fast. County records and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
