

When a dog attack leaves someone hurt around Atlanta, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia does not work that way. The question is normally whether the owner knew the animal **truck accident lawyer** was dangerous, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, which is why the first questions are about where the dog was and whether anyone contacted animal control.

These records fade fast. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
