

If you were riding and someone turned across your path around Atlanta, the assumption is already working against you.

Adjusters and jurors bring https://wiki-stock.win/index.php/Atlanta_Personal_Injury_Lawyer an assumption to these cases: that the rider was speeding, was weaving through traffic, or took a risk a car driver would not.

Sometimes that is accurate. Frequently the driver simply did not see the motorcycle and turned across it.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. Damage patterns do the arguing.

Injury severity cuts both ways. There is nothing around a rider, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk [truck accident lawyer](#) by riding at all.
