

When a dog attack leaves someone hurt in Georgia, Georgia works differently than people expect.

The claim generally turns on whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

These records fade fast. County records and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
