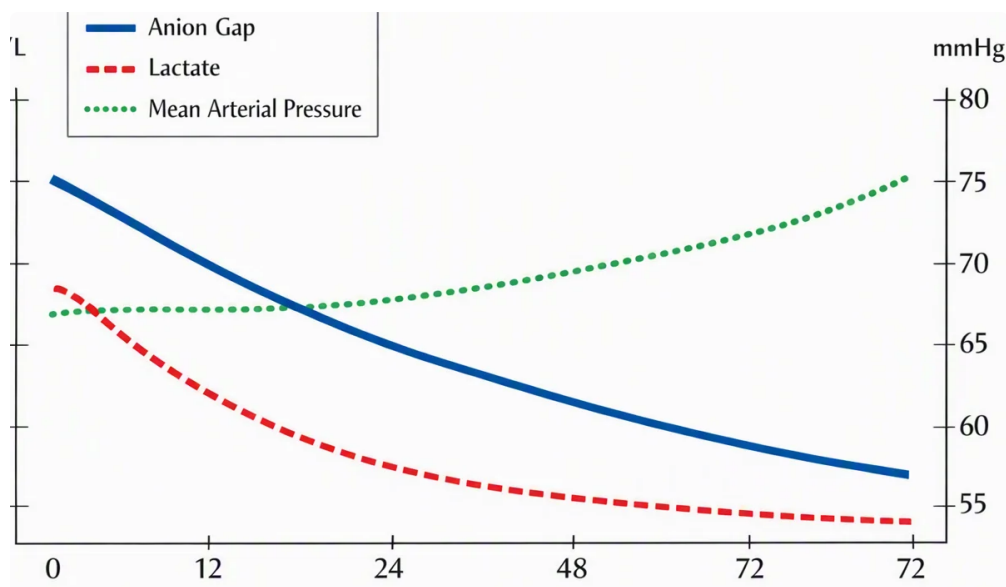


How the anion gap Reflects
