

When a dog attack leaves someone hurt around Atlanta, the rules may not be what you assume.

Some states hold the owner responsible no **truck accident lawyer** matter what. That is not the Georgia rule. The question is normally whether the owner [lawyer for big rig accident](#) knew the animal was dangerous, or whether a leash law was being broken at the time.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. Animal control files and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
