

A truck crash is not the same as a car crash. A loaded tractor trailer can weigh many times what your car weighs, and the injuries are usually far worse.

The difference starts in the first hours. Trucking companies frequently send an investigator to the scene the same day, while you [car accident injury lawyer](#) are still in the emergency room. They start protecting the company immediately.
