

When a [Check out the post right here](#) dog attack leaves someone hurt in the Atlanta area, Georgia works differently than people expect.

In some places an owner is liable automatically. That is not the Georgia rule. Usually it comes down to whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

Records disappear quickly here. County records and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
