



Laser medicine often gets flattened into marketing language, as if every device works the same way and every treatment promises the same result. That is not how real clinical practice looks. The differences between platforms matter, the settings matter, the tissue target matters, and the operator's judgment matters most of all. The 2940 nm Er:YAG wavelength behaves very differently. It is absorbed extremely strongly by water, far more strongly than CO2 lasers at 10,600 nm. Since human skin contains a great deal of water, this wavelength is highly effective for precise ablation. It can remove very thin layers of tissue with limited collateral thermal damage when used in certain modes. That precision is why Er:YAG has long been valued for resurfacing, textural refinement, treatment of superficial lesions, and procedures where controlled tissue removal matters.

The principle of selective photothermolysis

Wavelength determines what absorbs the light. Pulse duration determines whether the energy is delivered fast enough to confine heat to the target. Fluence, or energy per area, determines whether enough heat is generated to have a biological effect.

If the concern is diffuse redness in a patient with reactive skin, another strategy is safer. If the treatment area includes darker skin or recent sun exposure, settings must account for higher melanin competition. Devices do not make these judgments by themselves. The best outcomes happen when good technology meets careful treatment planning.

In many real treatment plans, they work best alongside injectables, surgery, medical-grade topicals, or energy-based treatments with different mechanisms.

One practical pattern shows up again and again. Patients often notice early changes in glow, smoothness, or tightness, then a slower phase where improvement feels subtle, then a more satisfying change after several weeks or after the second or third session. That lag is not a sign that the treatment failed. It reflects the tempo of tissue biology.

Fractional delivery and the logic of faster healing
