

If you were hurt on someone else's property in the Atlanta area, there is more to it than the hazard itself. Showing the spill was there is only half of it.

Under Georgia law you generally have to show that the property owner knew about the hazard, created it, or would have discovered it by inspecting the way a careful owner should.

This is the reason moving early matters. Store video cycles in a matter of days at many businesses, and without it you cannot establish how long the condition existed.

Incident reports are written by the party you will be making a claim against, which shapes what they contain. Sweep logs are just as important, because a policy nobody followed is its own kind of evidence.
