

When a rider is hurt and someone turned across your path around Atlanta, there is a prior you have to overcome.

Sometimes it fits. Frequently the driver simply did not see the motorcycle and turned across it.

Injury severity cuts both ways. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
