

If a dog bit you around Atlanta, Georgia works differently than people expect.

Records disappear quickly here. Prior complaints and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
