

If [18-wheeler liability lawyer](#) you ride and someone turned across your path in Georgia, you are starting from behind.

Injury severity cuts both ways. There is nothing around a rider, so the same impact produces far worse injuries. Expect an argument that choosing to ride was itself the risk.
