

If a dog bit you in Atlanta, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia does not work that way. The claim generally turns on whether the owner had reason to know the **truck accident lawyer** dog was vicious, or whether a leash law was being broken at the time.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

Records disappear quickly here. Animal control files and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
