

Tree removal looks simple from the curb. A truck arrives, ropes come out, limbs come down, wood disappears. What most property owners do not see is the decision-making that starts long before the first cut. The real work begins with judgment: is removal truly necessary, can the risk be reduced another way, what will happen to nearby structures, and how will the tree respond if part of the crown is reduced rather than the whole tree removed?

That is the difference between hiring a crew that can cut wood and hiring a Certified Arborist Consultation for Tree Removal Services. One can dismantle a tree. The other is trained in the art and science of tree care, has passed a comprehensive exam, continues education to maintain certification, and works under a code of ethics.
