

A rideshare wreck raises a question a normal car crash does not: which insurance policy actually applies. The answer depends on what the driver was doing at that exact moment.

When the app is off, the driver is just a driver, and their personal policy applies. When the app is on and they are waiting for a ride request, a smaller layer of coverage generally applies. Once a ride is accepted or a passenger is aboard, a far larger commercial policy usually applies.

That timing is not a technicality. It can decide whether the coverage available is modest or substantial, and the records that prove it sit with the rideshare company, not with [truck accident lawyer](#) you.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
