## Types of Permits You May Need

Depending on the nature and location of your event, you may need one or more of the following permits:



- Noise permits from DBKL or the relevant local council
- Temporary structure approvals for stages, tents, and booths
- Road closure permits for events that affect traffic
- Fire safety certificates for venues and temporary structures
- Health and sanitation permits for food and beverage vendors
- Copyright licences for music and performances

Each permit has its own application process, timeline, and requirements.

Missing even one can jeopardise your entire event.
