

If an electrical injury happened at work around Atlanta, several companies may share responsibility.

There is the property owner, the general contractor, the electrical sub, sometimes the utility, sometimes an equipment manufacturer, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it bars a suit against your employer. It does not stop a claim against another company that caused the danger.

The claim against the other company is normally where the meaningful money is, since comp covers none of the [18-wheeler collision attorney](#) human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, and none of that is available just for the asking.
