

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, often when the bills arrive or an adjuster calls.

Georgia handles a death case differently than most people expect. There are generally two separate claims. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious [atlanta personal injury attorney](#) suffering before death.

Who may bring the first claim follows an order set by statute. It generally begins with a surviving spouse, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or [car wreck lawyer Atlanta](#) a state agency can require written notice long before a lawsuit is due. Evidence also disappears, especially when a company vehicle or a business is involved.
