

If you were riding and were hit in Atlanta, there is a prior you have to overcome.

People arrive with a view already formed: that the rider was speeding, was weaving through traffic, or accepted a risk nobody else would.

Sometimes that is accurate. More often a driver looked and did not register a single headlight.

These cases get built on physical evidence rather than narrative, because narrative starts at a disadvantage. The geometry of the turn do the arguing.
