

If a dog bit you in the Atlanta area, the rules may not be what you assume.

In some places an owner is liable automatically. That is not the Georgia rule. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether anyone contacted animal control.

Records disappear quickly here. Animal control files and recollections both fade, and the animal may be rehomed or euthanized before its [Discover more here](#) history is ever documented.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
