- If there has been a recommendation for a MIAM, the conciliator needs to authorize the court application.

- Under area 10(1) of the Kid and Family Members Act 2014, it is now a requirement for a person to go to an Arbitration Details and Assessment Meeting [MIAM] prior to ensuring sort of applications to acquire a court order.
- In economic solution matters, the court has demonstrated its readiness to make expenses orders for failing to use a proper out-of-court process.
- Area 3c of the C100 allows exception from the MIAM demand where "the delay caused by participating in a MIAM would cause a threat of ... illegal removal of the kid from the UK."
