

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one eventually, usually when the bills arrive or an insurer calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other [car accident claim lawyer](#) belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. It generally begins with a surviving spouse, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. [truck accident lawyer](#) Evidence also thins out, particularly where a commercial vehicle or a business is involved.
