

When a dog attack leaves someone hurt around Atlanta, the legal standard surprises most people.

Certain states impose liability regardless of the animal's history. Georgia does not work that way. The question is normally whether the owner knew the animal was dangerous, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether a complaint was ever filed.

This evidence does not last. Animal control files and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
